We get the blow back of water when the roots block your wastewater pipe We have to pay \$350 every time this happens to have our pipes released. This has happened on two occasions. The trees you planted are the reason for the blockage. I have also had to get you to come out and trim the branches because they have become dangerous. They are your trees. My request is that you (a) take annual care of both tree roots and tree branches (b) reimburse us our money for dealing with your lack of care and (c) most importantly, please send out a contractor to urgently trim the roots because the flow through of shower water is slow because your pipe is partially blocked with said tree roots. The last time this happened we had debris shooting back into our shower because of the blockage. Please can you put Ambala Way in your annual roster or s chedule for root clearing and branch cutting please. I look forward to hearing back from you.
