## **LGOIMA IRO-665**



## Response to your information request regarding Rukutane Pump Overflow

Thank you for your request of 15 April 2024 for the following:

- 1. Details of all events since the most recent event (29-30/09/2022) referred to in the previous data WWL has provided me (see OIA IRO-302) when the Rukutane Pt pump capacity was exceeded, and untreated wastewater was discharged directly into the environment. Details should include: date, duration, volume of wastewater discharged, peak discharge rate.
- 2. Summary details of any enforcement actions taken against WWL or PCC in relation to breaches of the network consent since WWL's letter to me dated 12 October 2022 (in relation to OIA IRO-302).

Your request is responded to in accordance with the Local Government Official Information and Meetings Act (LGOIMA) 1987.

The response to your first request is enclosed as Appendix One following this letter. The Rukutane Point pump station does not record flow measurement/volume of wastewater discharged as there is no flow measurement instrumentation onsite. Consequently, this component of your request is refused under section 17(g)(i) of the LGOIMA as that the information requested is not held by the local authority. For your guidance, data related to the start and stop time of the overflow incident is recorded and provided in the appendix.

In response to your second request, this is refused under section 17(e) of the LGOIMA as the document(s) alleged to contain the information requested do not exist because Wellington Water has not received any enforcement actions regarding wastewater discharges from the Porirua City Council (PCC) Wastewater network. In regard to any enforcement actions taken against the PCC regarding the Rukutane Point pump station, this request would need to be sent to them.
