I refer to your clarified request of 25 October 2024 for information that Wellington Water Limited (WWL) has provided to its shareholding councils related to Seaview WWTP.

Wellington Water Limited is not in a position to respond on why the council did not decide to fund any particular part of the programme, as this decision is for the council. Page 12 of document titled: 2024_34 Investment Planning Advice HCC Step 2 direction on detailed investment options (9 October 2023) provides indicative recommended funding requirements for all Joint Venture Wastewater assets, including Seaview WWTP (Please refer to the Wastewater JV line in option 2, which shows the total investment recommended). The final funding decisions for all capital projects are confirmed in the memo titled HCC Three Waters LTP 2024-34 Final info pack and close out advice (15 August 2024).
