### Request for information

Thank you for your request of 12 May 2025, made under the Local Government Official Information and Meetings Act 1987 (LGOIMA – the Act) for the following:

*I understand that the Porirua (incl Northern Wellington) wastewater network is designed to allow discharge of untreated wastewater from the network and into the environment before it can reach the treatment plant. The overflow at Rukutane Point where wastewater from the Titahi Bay catchment is discharged directly to the CMA if the inflow exceeds the capacity of the pump at Rukutane Point is one example.*

*In this regard and in regard to the wider network, please provide me with the following information:*

- 1. Details of all events since 1 August 2024 when the Rukutane Pt pump capacity was exceeded, and untreated wastewater was discharged directly into the environment. Details should include: date, duration, volume of wastewater discharged, peak discharge rate.*
- 2. Details of all events since 1 August 2024 when the 'City Centre' at Lyttleton Ave pump capacity was exceeded, and untreated wastewater was discharged directly into the environment. Details should include: date, duration, volume of wastewater discharged, peak discharge rate.*
- 3. Summary details of any enforcement actions taken against WWL or PCC by GWRC in relation to any such overflows.*

\* Please note, the Rukutane sensor is a level sensor only, so no flow or volume data is available.

On the basis that the Rukutane Point Pump Station pump volume and peak flow is not available, we must respectfully refuse this part of your request under section 17(e) of the Act, as the information does not exist or cannot be found.

3. *Summary details of any enforcement actions taken against WWL or PCC by GWRC in relation to any such overflows.*

There are no records of any enforcement action relating to the Rukutane Point Pump Station discharges, and the City Centre Pump Station from August 2024.

Please note that decisions regarding enforcement action sit with GWRC, as the regulatory authority.

On that basis, we must respectfully refuse this part of your request under section 17(e) of the Act, as the information does not exist or cannot be found.
