Chris Hetherington is contemplating legal action over a stink from the Seaview Wastewater Treatment Plant that has locals gagging.

Hetherington lives 1km from the Seaview plant, where mayor Campbell Barry has warned the odour problem might be unfixable.

However, former Lower Hutt resident Don Gould, who acted as an advocate for Christchurch residents affected by a 2021 fire in the Bromley wastewater treatment plant, warned that legal action was not the answer.

Gould helped locals win a \$1 million compensation package as a result of the ongoing putrid odour caused by the fire. His advice was that Lower Hutt residents living with the pong needed to make more noise.

"I don't understand why they are not squealing more loudly."

While the Hutt City Council was planning to spend \$13m to reduce the

odour and a further \$225m upgrading the plant over the next decade, it has acknowledged the plant was nearing the end of its life.

Hetherington said the true scale of the odour problem was unknown, as a lot of local businesses were reluctant to comment fearing bad publicity.

He is prominent on social media page Stop the Stench, and said that with authorities apparently reluctant to address the issue, he planned to speak with neighbours and local Māori about taking legal action.

As well as the bad odour, the plant has an ongoing issue with discharges into the Waiwhetū Stream, which chief executive of TeĀtiawa Taranaki Whānui Puketapu-Dentice has said is offensive, as their urupa is next to stream and the treatment plant can be smelled when they have funerals.

Gould said he could not understand why Lower Hutt residents had been so passive.

His experience in Bromley taught him

that councils would not take any action unless the community fought for it and locals had to be far more vocal.

Legal action would be highly risky, he warned, as the chance of winning was small.

Christchurch residents had been approached by lawyers, but he said it was a high risk strategy and could leave Hutt residents with a huge legal bill.

Lower Hutt-based councillor Simon Edwards said although "residents' outrage and disgust at the current stench issues from the Seaview plant are absolutely valid and understandable", there was no easy fix.

"There had to be a balance between what needs to be done, and what residents can afford."

The Hutt City council had put up rates by 16.9% this year to try and catch up on the decades of underinvestment in three waters infrastructure, isentia

Edwards said. The council had also increased debt, yet Wellington Water had said it was still underinvesting by \$1 billion over the next decade.

"There's no silver bullet. We're all facing massive costs. On top of which, as *The Post* article notes, the Seaview plant is on land threatened by sea level rise. It is not a simple problem."

Gould said there should be monitoring of the odour beyond the plant's boundaries to better understand the level of the problem.

Wellington Water chair Nick Leggett has said he agreed with Barry that the plant's long term future was questionable.

In the long run, the new entity Local Water Well Done replacing Wellington Water would have to look at the issue of building a replacement plant.

Wellington Water's immediate focus was on finding a solution to reduce the impact on neighbours.

"This is impacting people's daily life and work, and at home, in the short term we have to find a solution."
