

## Private Drainage - Wastewater Lateral Cross Connected into Stormwater Network (Cross Connection)

Notice of works required

Wellington Water have identified an issue with your private wastewater drainage system. Your wastewater lateral is cross connected into the stormwater network at and Aro. As a result of this issue your private wastewater drainage pipe is discharging into the stormwater network.

Under the LGA 1974 Section 459 clause (1f) and subsection 6, Council is entitled to notify and ensure a property owner constructs and maintains private drainage services to effectively and responsibly drain to a required public network without causing a nuisance or cause harm to public health, safety or adverse effects to the environment.

Please arrange for a plumber or drain layer to investigate the matter further and attend to this issue as soon as possible.

You must have the works completed within 14 days of this notice and let us know that the works are completed. If the above works are not completed in the time frame specified, Wellington Water may thereafter authorise the works to be carried out on behalf of the owner under Section 186 and recover all costs under Section 187 of the LGA 2002.

We understand that this is a challenging time and there may be level of difficulty in arranging for this issue to be fixed. If this is the case, we are more than happy to answer any questions you may have on the matter.

Please let Wellington Water know once the works have been completed. On behalf of Wellington Water, we appreciate your attention to this issue.


