### Official information request regarding planned public works in 2024/25 for Mount Victoria

Thank you for request dated 2 April 2024 requesting the following information under the Local Government Official Information and Meetings Act 1987 (the Act).

*I would like to please request in accordance with LGOIMA the details of all public works planning and funded for 2024/25 for the suburb of Mount Victoria (including the Town Belt) and Kent/Cambridge Terraces.*

- 1. Specifically I am interested in the name, address, a description of the works to be completed, and budgeted amount for each project or initiative.*
- 2. This might include planned maintenance works and new works - and the value of any budgets for responsive maintenance where these exist for the suburb.*
- 3. I am primarily interested in physical works, including include waters, roads, public facilities, parks/reserves, and other infrastructure.*

Wellington Water understands that you submitted the same request to Wellington City Council, and that they are responding to information requested for parks and recreation, roads, footpaths, access ways and public facilities.

In response to your requests I refer you to Wellington City Council's webpage: <https://www.letstalk.wellington.govt.nz/three-waters-funding> which refers to the link about investment in our three waters network.

Specific details relating to Wellington Water's 2024/25 Capital (capex) and Operational (Opex) programme remain unconfirmed as they are subject to Wellington City Council's Long-Term planning that closed its consultation process on 12 May at 11:59pm. The Council is now reviewing the received feedback before deliberation and final approval meetings in June. The confirmed programme between Wellington City Council and Wellington Water will be released by 1 July 2024. In reference to the LGOIMA this means that your request is refused under section 17(d) *as the information will soon be publicly available.*

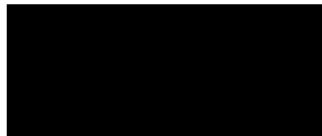
