Specialist Equipment	Ensure specialist equipment required is available for utilisation. If entering confined space have required equipment – tripod, safety harness and gas detector.			
Specialist Materials & Parts	Ensure you have loaded up all the required parts and materials required to undertake the maintenance work to be completed.
