Question One: When exactly did they start the sampling, was it February this year?

Answer...

The sampling was being taken as part of the drainage investigation teams catchment work that targets faults on private and public drainage to improve water quality of our rivers and stream.

Intergroup NZ Ltd are subcontracted to provide support to our drainage inspection crews.

The drainage investigation team was established in January 2021 and the first E-Coli samples were collected as part of this work in the Titahi Bay catchment on Tuesday 22 February 2021.

Question Two: Did they wait for a fine week to take samples?

Answer...

Sampling was taken at least 48 hours after rainfall.

Question Three: Are the results (reports) available to the public?

Answer...

Results from Monday 29 August are attached in our email response to you, titled 'Food and Water Testing Analytical Report, Tuesday 30 August 2022'.

Furthermore, please find attached the 'Results from 29 August 2022'

Question Four: Why only two a year?

Answer...

The sampling is taken routinely but not on a specific schedule in locations targeted in catchments to identify and divide sub-catchments. The sampling helps the drainage investigation team target or identify specific streets, pipes or catchments to further identify faults on private and public networks in sub-catchments.

Question Five: Marie is concerned that signage on the beach warning of potential pollution is not consistent. Photos attached. She believes signs like the one at the south end should be placed at all streams feeding into the Bay.

Answer...

The signage is inconsistent as they were put up for different purposes.

The sign at the culvert mouth is open while the discharge from the culvert still shows sign of contamination. It advises people to stay away from the "freshwater" stream running across the beach, nothing to do with the sea.

The other three signs are linked to the WWTP Consent. They are opened when the WWTP is discharging to the beach and closed 48hrs after the discharge stops. If we were to keep the WWTP signs open permanently, then that advises beach uses that the WWTP is continuously discharging and to stay out of the sea


